6.2 Environmental precautions

12.2 Persistence and degradability

AEROBIC: Bis(2-methoxyethyl) phthalate was biodegraded 19.3% using an enzyme extracted from *Nocardia erythropolis*(1). When present at 3,000 ppm, the compound was not degraded after 40 days incubation at 30 deg C using the soil microbe *Pseudomonas acidovorans* 256-1(2).

12.3 Bioaccumulative potential

An estimated BCF of 1.4 was calculated in fish for bis(2-methoxyethyl) phthalate(SRC), using an estimated log Kow of 1.11(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

The Koc of bis(2-methoxyethyl) phthalate is estimated as 38(SRC), using a water solubility of 8500(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that bis(2-methoxyethyl) phthalate is expected to have very high mobility in soil.

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
