In rats, absorption of the color-producing components of caramel was determined by fecal extraction, & although the recoveries varied widely about one-third of color-producing components appeared to be absorbed, but no conclusions could be reached about the possible absorption of the colorless components.

## **6.1 Personal precautions, protective equipment and emergency procedures**

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
