#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

**12.2 Persistence and degradability**

PURE CULTURE: The average growth of the fungus *Aspergillus versicolor* and the bacterium *Pseudomonas acroginosa* on the commercial plasticizer ricinoleic acid, methyl ester, serving as the only carbon source, was 414 and 66 mg, respectively, after incubation for 7 days at 30 deg C; flasks contained 2.1 g of ricinoleic acid, methyl ester and 70 mL mineral salts and yeast extract solution(1).

**12.3 Bioaccumulative potential**

An estimated BCF of 370 was calculated in fish for ricinoleic acid, methyl ester(SRC), using an estimated log Kow of 6.48(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high(SRC), provided the compound is not metabolized by the organism(SRC).

**12.4 Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of ricinoleic acid, methyl ester can be estimated to be 3700(SRC). According to a classification scheme(2), this estimated Koc value suggests that ricinoleic acid, methyl ester is expected to have slight mobility in soil.

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

**Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
