#### If inhaled

## SECTION 12: Ecological information

### 12.1 Toxicity

- Toxicity to fish: LC50 - *Oncorhynchus mykiss* (previous name: *Salmo gairdneri*) - 21.6 mg/L - 96 h.
  - Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - 50 mg/L - 48 h.
  - Toxicity to algae: EC50 - *Pseudokirchneriella subcapitata* (previous names: *Raphidocelis subcapitata*, *Selenastrum capricornutum*) - 13.9 mg/L - 72 h.
  - Toxicity to microorganisms: NOEC - activated sludge - 100 mg/L - 14 d.

### 12.2 Persistence and degradability

AEROBIC: Dimethyl isophthalate, present at 100 mg/L, reached 94 to 102% of its theoretical BOD after 2 weeks using an activated sludge inoculum(1).

### 12.3 Bioaccumulative potential

An estimated BCF of 4 was calculated in fish for dimethyl isophthalate(SRC), using an estimated log Kow of 1.66(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of dimethyl isophthalate can be estimated to be 36(SRC). According to a classification scheme(2), this estimated Koc value suggests that dimethyl isophthalate is expected to have very high mobility in soil.

### 13.1 Disposal methods

**Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
