#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Emergency and supportive measures. Maintain an open airway and assist ventilation if necessary. Administer supplemental oxygen. An estimated BCF of <1 was calculated in fish for oxcarbazepine(SRC), using an estimated log Kow of 1.11(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of oxcarbazepine can be estimated to be 360(SRC). According to a classification scheme(2), this estimated Koc value suggests that oxcarbazepine is expected to have moderate mobility in soil.

### 13.1 Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
