**SECTION 4: First-aid measures****4.1 Description of necessary first-aid measures****If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

**Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

**Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

**Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

ACUTE/CHRONIC HAZARDS: This compound may cause irritation of the skin and mucous membranes. (NTP, 1992)

**4.3 Indication of immediate medical attention and special treatment needed, if necessary****Absorption, Distribution and Excretion**

Was observed in 24-hr urine samples collected at 14-day intervals from 6 sheep grazing pasture of oestrogenic clover from July to late October. Generally it occurred in only 1 urine sample at each collection but from mid-August to mid-September it was present in 3 or 4 samples.

**SECTION 5: Fire-fighting measures****5.1 Suitable extinguishing media**

Fires involving this compound should be controlled using a dry chemical, carbon dioxide, foam or Halon extinguisher. (NTP, 1992)

Flash point data for this compound are not available but it is probably combustible. (NTP, 1992)

Wear self-contained breathing apparatus for firefighting if necessary.

## **SECTION 6: Accidental release measures**

### **6.1 Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **6.2 Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **6.3 Methods and materials for containment and cleaning up**

Indigo is recovered from wastewater containing 0.1 kg/cu m by flocculation with 0.03 kg/cu m  $\text{CaCl}_2\text{-MgCl}_2$  & 2.3 kg/cu m  $\text{NaOH}$ .

### **7.1 Precautions for safe handling**

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

### **7.2 Conditions for safe storage, including any incompatibilities**

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning.
