## SECTION 4: First-aid measures

### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### 4.2 Most important symptoms/effects, acute and delayed

SYMPTOMS: Vapors cause irritation to eyes and mucous membranes as well as headache, respiratory distress, and loss of consciousness. Ingestion has similar effects plus nausea and vomiting. Contact with the skin may cause severe dermatitis. ACUTE/CHRONIC HAZARDS: This compound and its vapors are irritating to the skin, eyes, and mucous membranes. It may be corrosive and can be absorbed by the skin. When heated to decomposition it emits toxic fumes. (NTP, 1992)

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

## **6.2 Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

## **6.3 Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
