#### If inhaled

### 12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated for chloroacetic anhydride(SRC), using an estimated log Kow of -0.07(1,SRC) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low. Bioconcentration is unlikely to occur due to an estimated base-catalyzed second-order hydrolysis rate constant of  $1.9 \times 10^5$  L/mole-sec(SRC) which corresponds to half-lives of 37 and 4 seconds at pH values of 7 and 8, respectively(4).

### 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for chloroacetic anhydride can be estimated to be 3(SRC). According to a classification scheme(2), this estimated Koc value suggests that chloroacetic anhydride is expected to have very high mobility. An estimated base-catalyzed second-order hydrolysis rate constant of  $1.9 \times 10^5$  L/mole-sec(SRC) which corresponds to half-lives of 37 and 4 seconds at pH values of 7 and 8, respectively(3) will make it unlikely for chloroacetic anhydride to be mobile.

### 13.1 Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
